Hypernomicon User Guide

### Creating a debate record

Debate records form the base all other Hypernomicon record types branch off from. All records connect back to debate records and their tab. When creating your debate records, write accurate descriptions that remain general enough to connect to all the positions grounded in that debate.

#### To create a debate record

- 1. Navigate to the Problems/Debates tab.
- 2. Click New in the Sub-Debates panel

A new debate record displays with its own ID number.

- 3. Enter a name for the debate in the Name field.
- 4. Click Go:
- 5. Add a detailed description explaining the core question or issue in the description field.
- 6. Use the **Notes** section for additional context or personal observations.

Tip: In the record description, frame debates as questions rather than statements.

### **Collecting perspectives with Positions**

Positions are the answers given and stances taken within debates and about problems. Your position records will capture a range of views about your topics of interest. Each position record contributes to your database's catalog of perspectives.

### Creating a position record from the Positions tab

Debate records don't need to be created before entering a position, but every position belongs to a specific debate and should eventually link to it. The Problems/Debates tab includes a panel for entering positions, but you can also create a position record from the Positions tab.

#### To create a position record from the Positions tab

- 1. Navigate to the Positions tab.
- 2. Click Create New.
- 3. Enter a name for the position in the Name field.
- 4. Fill in the record description with the position's core daims.

Record types and their tabs

### Documenting discourse with Problems/Debates

The Problems/Debates tab centers your database at the heart of philosophy: its core problems and debates. This tab and its records form the foundation for your Hypernomicon database. Create records for the central debates in your research area.

Note: Records in the Problems/Debates tab are called "debate records."

### Getting to know the Problems/Debates tab layout

The Problems/Debates tab starts with the All Debates record. From here, you'll add debate records related to your research. See Figure 2.1 for the tab's layout and Table 2.2 for available user interactions.



Figure 2.1: Components of the Problems/Debates tab

Some actions you can take in the Problems/Debate tab include:

Ul Element	Actions
Name field	Add or change the name of the debate record.
Tree tab button	Navigate to the Tree view to see the debate in context of other records.
Unite options	Unite this record with a Term, Note, or Label.
Record description	Describe the philosophical problem/debate.
Positions panel	Click New to create a new position, Click Go to navigate to a related position.
Search Key field	Enter key terms from the record description as search keys.
Sub-debate panel	Click New to add a debate record, click Go to navigate to a related sub-debate,

# Barkerville Historic Site

Being part of Western North America's largest historic site for almost 10 years provided opportunties. I began as a street performer, writing my own monologues. In 2015, I was tasked with replacing the most popular educational-theatrical program on the site. My script went on to receive the "Visitor's Choice" designation, awarded by the CEO of after tabulating audience feedback cards. In 2017, I wrote another show. In 2020, I began writing grant proposals and internal policies for the company (still in effect to this day). One grant proposal secured \$630,000 in funding for a foundation for the historic theatre. Funny story about that grant. Ask me some time.

### Meeting WorkSafeBC Requirements: Occupational Road Safety

When used for work purposes, a vehicle is a workplace. The Workers Compensation Act (WCA) and the Occupational Health and Safety Regulation (OHSR) set out obligations that apply to work-related driving. Items below list applicable sections, state pertinent portions of each one, and provide examples of work practices and processes that employers, supervisors, and workers are responsible for following.

### **Employer Responsibilities - Drivers**

The OHSR identifies employer responsibilities to ensure that only qualified, competent workers operate vehicles for work, and to make sure they operate vehicles in accordance with applicable laws

#### Competency of operators

OHSR 16.4

#### Regulation:

(1) A person must not operate mobile equipment unless the person has:

a. Received adequate instruction in the safe use of the equipment, in accordance with Barkerville's workplace driver and passenger orientation & training materials and safe work procedures.

b. Demonstrated to a qualified supervisor or instructor competency in operating the equipment

#### Therefore

Before allowing an worker to drive for work, they must:

- . Hold valid and class-appropriate driver's licence for the vehicle(s) they are assigned to drive
- Receive a briefing on safe use of the vehicle qualified supervisor or instructor.
- Complete an initial assessment to confirm the worker has the necessary driving skills to safely
  operate the vehicle.

It is management's responsibility to keep records of workers who have demonstrated competency and are authorized to drive for work.

#### **Brief Project Description**

Barkerville's Theatre Royal has been hosting seasons of five theatre for over 150 years. As the building in which cultural and heritage presentations are centralized at Barkerville Historic Town & Park: the targest beritage site in western North America-the theatre is the most well-used building in Barkerville, every year, the structure is home to special events, presentations, travelling delegations, big-ticket performers, and a full season of emtertaining, educational, and accessible live theatre created and performed by Barkerville's own team of misseum theatre professionals and cultural stoycellers.

Maintaining and revitalizing the building is of utmost importance for delivering on Barkerville's mandate to strengthen cultural heritage in its traditional and globally-renowned methods of combining stage arts and history in a way that visitors of all ages and cultural backgrounds can appreciate, enjoy, and learn from.

Although the first Theatre Royal was built in 1868, the newest iteration has been standing since 1937. As of right now, there are five major areas of improvement that will be required for Barkerville's Theatre Royal to continue to optimally fuffill its purpose and grow in utility and functionality; improvements are needed with the foundation, lighting, concession area, and seating, as well as accessibility upgrades required of the entrance-way and its public washroom.

### Detailed List of Project Works

Lighting System Assessment and Implementation:

The current lighting is energy inefficient and hazardous. A proper engineering assessment of roof-structure is required to determine how a lighting system can best and most safely be managed. Then, a state of the art lighting system that protects the building from fire and protects workers from other potential safely hazards

#### Foundation

Requires improvement. Eventually, structural heritage assets such as the Theatre Royal require serious foundation work to ensure the long-term viability and protection of the asset. The Theatre Royal is due for this, and moving forward on this immediately is in the best interest of the site, province, and building in terms of both financial priority and maintaining structural and historical integrity.

#### Seating Area

Current benches for seating are outdated, poorly designed for safety, and most importantly, they are not easily moved or reconfigured. Due to the need for unpredictable seating-plan re-arrangement in a COVID-afflicted reality, seating that is more flexible and contemporary will be required.

#### Concession area

Substandard in terms of safety, practicality, and aesthetics: generally, outdated and in need of improvement.

#### Entrance & Washroom Accessibility


Re-design must be done to ensure modern standards of accessibility and inclusivity, which allow for people with mobility issues to safely and conveniently access the building and its amenities.





# Personal writing projects







